UVOD

Nedelja privatnosti je godišnji događaj koji se održava tokom poslednje nedelje januara u Beogradu, povodom obeležavanja Dana zaštite podataka o ličnosti (28. januara). Nedelja privatnosti prvi put je održana 2021, deset godina nakon što su Partneri Srbija i Poverenik za informacije od javnog značaja i zaštitu podataka o ličnosti, zajedno po prvi put u Srbiji obeležili Dan zaštite podataka o ličnosti.

Ove godine, od **29-31. Januara**, održaće se peta po redu Nedelja privatnosti, kroz četiri panela, četiri radionice i dve prezentacije, sa preko 30 govornika i govornica iz civilnog, javnog i privatnog sektora kao i akademske zajednice.

Događaj se organizuje kako bi se unapredilo razumevanje javnosti o savremenim izazovima u oblasti zaštite prava na privatnost, i stvorio prostor za diskusiju o unapređenju zaštite ovog prava.

Ovaj događaj je podržan od strane **BIRN Hub-a, Delegacije Evropske unije u Srbiji, Fondacije za otvoreno društvo - Western Balkans, Fondacije Metamorfozis, Ministarstva spoljnih poslova Kraljevine Norveške i Misije OEBS-a u Srbiji.**

INTRODUCTION

Privacy Week is an annual event that takes place during the last week of January in Belgrade to mark Personal Data Protection Day (January 28). It was held for the first time in 2021, ten years after Partners Serbia, together with the Commissioner for Information of Public Importance and Personal Data Protection, marked the Personal Data Protection Day for the first time in Serbia.

This year, the fifth Privacy Week will take place from **29 to 31 January**. It will consist of four panels, four workshops, and two presentations, with over 30 speakers from the civil, public, private, and academic community.

The event is organized to improve public understanding of contemporary challenges in privacy protection and to create a space for discussion on improving this right.

The event is supported by **BIRN Hub, the Delegation to the European Union to Serbia, the Open Society Foundations - Western Balkans, the Metamorphosis Foundation, the Ministry of Foreign Affairs of the Kingdom of Norway and the OSCE Mission to Serbia.**

Workshop "Shaping a Realistic Narrative for Holistic Safety of Women in Digital Space: Community, Resilience and Guerrilla Tactics"

Given the recent developments and changes in Big Tech content moderation and safety policies, the digital environment is set to become a space for further infringement on women's rights - particularly rights to privacy and freedom of expression. For this reason, this workshop, organized by Partners Serbia in cooperation with Association Atina and Pen to Paper, aims to reshape traditional narratives about women's safety in the digital space. Through group work, for two hours of the workshop, we will look at widespread traditional narratives that shift the responsibility for online safety from perpetrators to women. The workshop aims to change existing and create new narratives that point to the importance of organizing together.

The workshop is designed for civil society and informal group activists, digital activists and journalists.

She is a co-founder of Pen to Paper, and she collaborates with Jennifer Adams. She lives and works between the Netherlands and the Western Balkans region.

Panel I: ZDRAVITAS - opportunities, challenges and responsibility

A11 Initiative for Social and Economic Rights

The announcement of the establishment of the Zdravitas platform has sparked a fierce debate in public in 2024, triggering numerous dilemmas, doubts, and concerns among citizens. To shed light on the role and purpose of the Zdravitas platform, to critically look at the advantages and disadvantages of digitalization in the public sector with a special focus on the Zdravitas platform, as well as to promote transparency and accountability in the spending of public funds, Partners Serbia and Initiative A 11 are organizing an interactive panel discussion where representatives of the public and private sectors, as well as representatives of teachers, parents and civil society will discuss the advantages and risks of introducing digital platforms in the education sector and public administration in general, responsible spending of budget funds for these purposes, and the protection of the rights of citizens, especially children and other vulnerable categories, in these processes.

Working language of the panel is Serbian.

Panel I: Od zaštite podataka do zaštite pojedinaca: sinergija borbe protiv diskriminacije i zaštite podataka

Ovaj panel će istraživati odnos između zaštite privatnosti i ličnih podataka i borbe protiv diskriminacije. Kako kršenje privatnosti često dovodi do diskriminacije, ali i do kršenja drugih ljudskih prava (poput slobode udruživanja, slobode izražavanja i sl.), predstavnici nezavisnih tela za borbu protiv diskriminacije i zaštite podataka o ličnosti i civilnog sektora iz Srbije i EU, razgovaraće se o mogućnostima za stvaranje sinergije između mehanizama i okvira za zaštitu ovih prava. Panel I: From Protection of Data to Protection of Individuals: Synergy between Anti-Discrimination and Data Protection

This panel will explore the relationship between protecting privacy and personal data and anti-discrimination. As violations of privacy often lead to discrimination, as well as to violation of other human rights (such as freedom of association, freedom of expression, etc.), representatives of independent anti-discrimination and personal data protection bodies and the civil sector from Serbia and EU, will discuss possibilities for the creation of synergy between mechanisms and frameworks for protection of these rights. The panel will also address the challenges of using algorithms and AI to detect human rights violations and the need for a holistic approach to human rights protection.

Brankica Janković, master pravica, izabrana je za Poverenicu za zaštitu ravnopravnosti Republike Srbije prvi put u maju 2015, i drugi put u novembru 2020. u Narodnoj skupštini. Diplomirala je na Pravnom fakultetu Univerziteta u Beogradu, master studije završila je na Pravnom fakultetu Univerziteta u Novom Sadu i doktorantkinja je na Fakultetu za bezbednost u Beogradu. Govori engleski i ruski. Predaje na master studijama na predmetu Multikulturalni socijalni rad – antidiskriminacione politike i prakse na Fakultetu političkih nauka u Beogradu, kao i na Visokim studijama bezbednosti Škole nacionalne odbrane Vojske Republike Srbije, kao gostujući predavač. Brankica Janković je dobitnica nekoliko nagrada i priznanja, među kojima i „Doprinos godine Evropi“ za 2018. i OEBS-ove nagrade „Ličnost godine“ za 2017, Nacionalnog priznanja za doprinos razvoju sistema socijalne zaštite koju dodeljuje Asocijacija socijalne zaštite Republike Srbije, „Petar Manojlović“ za doprinos unapređenju položaja starijih i „Zlatni točak“ za doprinos zaštiti ljudskih prava pripadnika romske nacionalne manjine, koju dodeljuje Nacionalni savet Roma u Srbiji.

Brankica Janković, LL.M., was elected Commissioner for Protection of Equality of the Republic of Serbia by the National Assembly for the first time in May 2015 and for the second time in November 2020. She graduated from the University of Belgrade Faculty of Law, completed her master's studies at the University of Novi Sad Faculty of Law, and is a doctoral student at the Faculty of Security Studies in Belgrade. She speaks English and Russian. She is a lecturer at the master's degree course Multicultural Social Work and Anti-Discriminative Policies and Practices at the Faculty of Political Sciences in Belgrade and a guest lecturer at the Higher Security Studies of the National Defense School of the Army of the Republic of Serbia. Brankica Janković won many awards and recognitions, including the 2018 Contribution of the Year to Europe award, OSCE's 2017 Person of the Year award, the National Award for the Contribution to the Development of the Social Protection System awarded by the Social Protection Association of the Republic of Serbia, the Petar Manojlović award for her contribution to the improvement of the position of the elderly and the Golden Wheel award for her contribution to human rights protection of the Roma national minority members, awarded by the Roma National Council in Serbia.



Tobias Judin je šef za međunarodne poslove u Norveškom organu za zaštitu podataka. Njegove odgovornosti uključuju međunarodnu saradnju, prekogranično sprovođenje i međunarodni prenos podataka. Pored toga, on predstavlja Norvešku u Evropskom odboru za zaštitu podataka i kopredsedavajući je Međunarodne radne grupe za sprovođenje Globalne skupštine privatnosti. Tobias je po obrazovanju pravnik, tehnolog i sinolog.

Tobias Judin is head of international affairs at the Norwegian Data Protection Authority. His responsibilities include international cooperation, cross-border enforcement, and international data transfers. Additionally, he represents Norway on the European Data Protection Board and is a Co-Chair of the Global Privacy Assembly's International Enforcement Working Group. Tobias is a lawyer, technologist, and sinologist by education.



Anastasia Karajani je doktorantkinja na LSTS istraživačkoj grupi Pravnog i kriminološkog fakulteta VUB-a. Njena akademska pozadina se uglavnom zasniva na međunarodnom i evropskom pravu o ljudskim pravima, pošto je magistrirala na Odseku za međunarodne studije Aristotelovog univerziteta u Solunu. Tokom magistarskih studija, godinu dana je bila studentkinja na razmeni na Fakultetu međunarodnog prava KU Leuven. Takođe je bila gostujuća istraživačica u istraživačkom timu iCourts na Univerzitetu u Kopenhagenu. Pored svojih akademskih interesovanja, Anastasia je aktivistkinja za digitalna prava otkako je suosnivala DATAWO, organizaciju civilnog društva sa sedištem u Grčkoj, koja se zalaže za rodnu ravnopravnost u digitalnoj eri. Anastasia Karajani je bila ambasadorka MozFesta 2023 i dobitnica je Nagrade Mozilla Fondacije za projekat „Feministički rečnik u veštačkoj inteligenciji“ radne grupe Trustworthy Artificial Intelligence.

Anastasia Karagianni is a Doctoral Student at the LSTS Research Group of the Law and Criminology Faculty of VUB. Her academic background is mainly based on International and European Human Rights Law, as she holds an LL.M. from the Department of International Studies of the Aristotle University of Thessaloniki. During her master's studies, she was an exchange student for one year at the Faculty of International Law at KU Leuven. She has also been a visiting researcher on the iCourts research team at the University of Copenhagen. In addition to her academic interests, Anastasia has been a digital rights activist since she co-founded DATAWO, a civil society organization based in Greece that advocates gender equality in the digital era. Anastasia Karagianni was MozFest Ambassador 2023 and Mozilla Awardee for the project "A Feminist Dictionary in AI" of the Trustworthy Artificial Intelligence working group.

Da li veliki jezički modeli treba da prođu obuku o privatnosti?

Upotreba veštačke inteligencije u medicinske svrhe, uključujući medicinsku dijagnostiku, prevenciju i lečenje, ima ogroman potencijal. Međutim, modeli veštačke inteligencije u ovom sektoru su zasnovani na velikim količinama osetljivih podataka koji zahtevaju primenu osnovnih principa i obaveza zaštite privatnosti, kao što su privatnost po dizajnu i privatnost po podrazumevanoj vrednosti, tokom razvoja i upotrebe bilo kog sistema veštačke inteligencije. Kroz kratku diskusiju između Anđelke Zečević, stručnjakinje za veštačku inteligenciju i Tamare Vučenović, istaknute medijske ekspertkinje specijalizovane za pitanja digitalne tranzicije, publika će biti upoznata sa značajem i tehnikama pripreme skupova medicinskih podataka za pravnu i etičku upotrebu veštačke inteligencije, fokusirajući se na proces deidentifikacije medicinskih podataka.

Enlightening talk: Should Large Language Models Attend Privacy Training?

De-identification of medical data for ethical deployment of AI -

The use of artificial intelligence for medical purposes, including medical diagnostics, prevention, and treatment, has vast potential. However, AI models in this sector are based on large volumes of sensitive data that require the implementation of core privacy-protection principles and obligations, such as privacy by design and privacy by default, throughout the development and use of any AI system. Through a brief discussion between Anđelka Zečević, an AI expert, and Tamara Vučenović, a prominent media professional specializing in digital transition issues, the audience will be introduced to the importance and techniques of preparing medical data sets for the legal and ethical use of AI, focusing on the process of de-identification of medical data.



Anđelka Zečević je istraživačica u oblasti obrade prirodnih jezika na Matematičkom institutu Srpske akademije nauka i umetnosti. Školovala se na Matematičkom fakultetu Univerziteta u Beogradu na Katedri za Računarstvo i informatiku. Doktorsko istraživanje na temu sumarizacije dokumenata i diverzifikacije informacija je realizovala u Majkrosoftovom razvojnom centru u Beogradu. Učestvovala je na većem broju akademskih projekata koji se bave digitalizacijom, pretraživanjem informacija i razvojem algoritama mašinskog učenja. Trenutno su joj u fokusu interesovanja tehnike ispitivanja kapaciteta velikih jezičkih modela i njihova evaluacija. Uz naučni i istraživački rad, Anđelka radi na edukativnim projektima. Jedan je od osnivača JerTeH-a, organizacije koja promoviše razvoj resursa i tehnologija za obradu srpskog jezika.

Anđelka Zečević is a researcher in natural language processing at the Mathematics Institute of the Serbian Academy of Sciences and Arts. She studied at the Faculty of Mathematics, University of Belgrade, Department of Computing and Informatics. She completed her doctoral research on document summarization and information diversification at Microsoft's development center in Belgrade. She participated in many academic projects dealing with digitization, information retrieval, and the development of machine learning algorithms. Currently, her focus is on the techniques of testing the capacity of large language models and their evaluation. In addition to scientific and research work, Anđelka works on educational projects. He is one of the founders of JerTeH, an organization that promotes the development of resources and technologies for processing the Serbian language.

Tokom ove radionice predstavimo koncept „Pay or Okay“ koji usvaja sve više onlajn platformi u Evropskoj uniji, uključujući i onlajn medije. Korisnicima se postavljaju dve mogućnosti pod kojima mogu da pristupe platformi: da novcem plate pristup ili da daju pristanak za obradu podataka koja omogućava ciljano personalizovano oglašavanje. Problematizovaćemo ovakvu praksu sa stanovišta pravnog okvira zaštite podataka o ličnosti i predstaviti aktuelne pravne procese s tim u vezi. U nastavku ćemo saznati kako onlajn mediji u Srbiji obrađuju podatke korisnika, da li upotrebljavaju kolačiće i trekere, na koji način informišu posetioce o svojim praksama obrade podataka i šta možemo zaključiti o poslovnom modelu medija na osnovu prakse obrade podataka o korisnicima.

During this workshop, we will present the "Pay or Okay" concept, which is being adopted by increasingly more online platforms in the European Union, including online media. Users are given two options to access the platform: to pay for access or consent for data processing that enables targeted, personalized advertising. We will problematize this kind of practice from the point of view of the legal framework for protecting personal data and present the current legal processes in this regard. In the following, we will find out how online media in Serbia process user data, whether they use cookies and trackers, how they inform visitors about their data processing practices, and what we can conclude about the media's business model based on user data processing practices.

Discussion on Media Data Insight

During this talk, we will discuss the standards of protection of citizens' personal data within the online media business in Serbia and talk with the experts who have analyzed several informative editorial sites dedicated to news and current events.

Ovaj panel istražuje praksu nezakonitog nadzora i cenzure na Zapadnom Balkanu, sa posebnim fokusom na nalaze nedavnog izveštaja organizacije Amnesty Internešenal, ali i drugih organizacija i medija, o upotrebi špijunskih softvera od strane službi bezbednosti za neovlašćeni nadzor aktivista, novinara i drugih pojedinaca. Panelisti će analizirati kako ove prakse narušavaju ljudska prava, uključujući slobodu izražavanja, pravo na privatnost i bezbednost građana, te kako doprinose širenju straha i autocenzure u društvu. This panel explores the practice of illegal surveillance and censorship in the Western Balkans, with a particular focus on the findings of a recent report by Amnesty International, as well as other organizations and media, on the use of spyware by security services for unauthorized surveillance of activists, journalists, and other individuals. Panelists will analyze how these practices violate human rights, including freedom of expression, the right to privacy and security of citizens, and how they contribute to spreading fear and self-censorship in society. The discussion will highlight examples of systemic rights violations through digital surveillance, the impact of these practices on media freedom and democracy, legal protection mechanisms, and international initiatives that can contribute to reducing abuses.

U okviru ovog izlaganja biće predstavljen najnoviji monitoring izveštaj Balkanske istraživačke mreže Srbije (BIRN Srbija). Izveštaj analizira učestalo kršenje prava na privatnost u onlajn medijima u Srbiji tokom 2024. godine, uključujući senzacionalističko izveštavanje o nasilju, nestalim osobama i građanskim protestima. Tokom protekle godine mediji su često objavljivali privatne podatke maloletnika i građanskih aktivista, koristeći ih za senzaciju ili političku diskreditaciju. Polarizovana medijska scena i slaba regulativa dodatno pogoršavaju problem. Tokom predstavljanja ćemo razgovarati o tome koji su novi trendovi, koje loše prakse ostaju duboko ukorenjene, i šta je mogući odgovor na njih.

The latest monitoring report by the Balkan Investigative Reporting Network (BIRN Serbia) will be presented during this brief insight. The report analyzes the frequent violation of the right to privacy in online media in Serbia during 2024, including sensationalist reporting on violence, missing persons, and citizens' protests. Over the past year, the media have frequently published private data of minors and activists, using it for sensationalism or political discrediting. A polarized media landscape and weak regulations further worsen the problem. During the presentation, we will discuss the new trends, the harmful practices that remain deeply ingrained, and potential responses to them.



Tanja Maksić je programska koordinatorica i članica je tima BIRN Srbija od 2010. Osmišljava i vodi projekte iz oblasti medijskih politika i dobrog upravljanja. This workshop will bring together representatives of relevant institutions to explore key aspects of DSA implementation in the context of harmonizing the domestic legal framework with European Union regulations. The focus of the discussion will be on the role of state authorities in the implementation of DSA, with special reference to the protection of user rights, the regulation of online platforms, and the provision of mechanisms for removing illegal content. Participants will consider how new concepts, such as Digital Service Coordinators and Trusted Notifiers, can improve the digital space's security and transparency, emphasizing the protection of vulnerable social groups, such as children.

In 2014, he joined the Legal Department of the Regulator as a senior legal advisor, where he worked on drafting all bylaws passed by the Regulator, drafting opinions from the scope of work of the Regulator, as well as representing the Regulator before the courts. In 2019, he was appointed Secretary General, where he gained experience managing the Regulator with a special emphasis on international cooperation.
